Resolution 2004-01

A Resolution to encourage the Douglas County Commission and the East Fork Fire and Emergency District to proceed with the planned construction and operation of the Fire Station planned for North Sunridge Drive

Whereas, the Indian Hills General Improvement District (the District) has functioned successfully for 30 years as a multi-purpose unit of local government with responsibilities including the provision of safe streets, and sufficient public parks and recreation facilities to a steadily and rapidly growing number of residents, and including the provision of water and sewer services to a growing number of residences and commercial establishments; and

Whereas, the District's resident tax payers have and continue to contribute to the several funding streams which afford the development and provision of public services, among them the provision of fire protection and emergency medical and ambulance services, both within the District and surrounding area as well as across the entirety of Douglas County; and

Whereas, there has been collected for a number of years a specific and designated amount of tax funds the use of which includes the planned construction and operation of a new Fire and Emergency Station, on lands provided now through an agreement with the federal Bureau of Land Management (BLM), and situated alongside North Sunridge Drive; and

Whereas, it is incumbent upon the Board of Trustees of the District to be mindful of the efficient and effective use of public funds expended for the development of public services, including water and sewer infrastructure, specifically within its area of responsibility and generally within the region,


NOW, THEREFORE, BE IT RESOLVED, by the Indian Hills General Improvement District Board of Trustees that the Douglas County Commissioners, acting as the Board of Trustees of the East Fork Fire and Emergency District, are encouraged

- a) to reconsider any decision which may have been made to delay construction of the programmed new Fire Station at North Sunridge Drive, on lands provided through agreement with the BLM, and
- b) to proceed with implementation of this planned improvement in public service to the developing north county area and its growing number of county residents, and
- c) to accept the District's continuing offer to waive all sewer and water service connection fees to this important public service improvement and to proceed to connect it to the readily-available District infrastructure.


